

## Vetlink Privacy Policy

This Privacy Policy describes how your personal information is collected, used, and shared when you visit or make a purchase from [www.vetlink.co.za](http://www.vetlink.co.za) (the "Site") or sites managed by Vetlink.

### PERSONAL INFORMATION WE COLLECT

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information."

We collect Device Information using the following technologies:

- "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit <http://www.allaboutcookies.org>.
- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

Additionally when you make a purchase or attempt to make a purchase through the Site, we collect certain information from you, including your name, billing address, shipping address, payment information (including credit card numbers, email address, and phone number. We refer to this information as "Order Information."

We also collect information relating to your registration such as occupation, council numbers and electronic contact details referred to as "Registration Information"

We may collect, or process on behalf of our customers, the following categories of personal data when you use or interact with our Products:

- Account Information
- Profile and Participant Information
- Contacts and Calendar Integrations
- Settings
- Registration Information
- Device Information
- Meeting, Webinar, and Messaging Content and Context
- Product and Website Usage
- Communications with organisers
- Information from Partners

When we talk about "Personal Information" in this Privacy Policy, we are talking both about Device Information, Order and Registration Information.

### HOW DO WE USE YOUR PERSONAL INFORMATION?

We use personal data to conduct the following activities:

- **Provide Products and Services**
- **Marketing and Promotion for sponsors of the event during and before the event**
- **Authentication of accounts**
- **Communicate with You**

We use the Order/Registration Information that we collect generally to fulfill any orders or registrations placed through the Site (including processing your payment information, arranging for shipping, and providing you with invoices and/or order /registration confirmations).

Additionally, we use this Order/Registration Information to:  
Communicate with you; Screen our orders for potential risk or fraud; and  
When in line with the preferences you have shared with us, provide you with information or advertising relating to our products or services.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns).

#### SHARING YOUR PERSONAL INFORMATION

We share your Personal Information with third parties to help us use your Personal Information, as described above. For example, we use Airmeet as event platform--you can read more about how Airmeet uses your Personal Information here: <https://www.airmeet.com/hub/privacy-notice/>.

We also use Google Analytics to help us understand how our customers use the Site--you can read more about how Google uses your Personal Information here: <https://www.google.com/intl/en/policies/privacy/>. You can also opt-out of Google Analytics here: <https://tools.google.com/dlpage/gaoptout>.

Finally, we may also share your Personal Information to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights

#### ADVERTISING

As described above, we use your Personal Information to provide you with targeted advertisements or marketing communications we believe may be of interest to you. When you place an order through the Site, we will maintain your Order Information for our records unless and until you ask us to delete this information.
